I hereby apply for a hunting license and certify that the statements contained herein are true and correct; and by signing my name hereto, I hereby waive for myself, my heirs, executors, administrators, assigns and assignees, any and all claims and demands against the United States, the State of Hawaii, the City and County of Honolulu, the counties of Hawaii, Maui and Kauai, their respective officers, agents or employees, or the owner, lessee or tenant of any area set aside for public hunting, for personal injury, property damage or death accruing or arising in any manner whatsoever while exercising the privileges granted by this license, or while using the public hunting area; and further agree to defend, indemnify and hold harmless the State of Hawaii, its officers, agents and employees from and against all claims or demands for personal injury, property damage or death accruing or arising in any manner whatsoever from the exercise of any privileges granted by this license, I assume the risk of all dangerous conditions in and about said properties, including the properties outside of said specified area, and waive any and all specific notice of the existence of such conditions.
